Dear camping friends,

Camping Lido Toce welcomes you and wishes you a wonderful holiday and a pleasant and relaxing stay. To ensure that all our guests feel at home on our campsite and can use the campsite facilities without obstruction, and, above all, to guarantee peace, tidiness, and tranquillity for all our guests, the following campsite rules must be observed.

Arrival and registration:

Upon arrival, please register immediately at the reception with your valid identity card or passport. With your registration you automatically accept our campsite rules. All persons travelling with you will be registered by name and date of birth. You will also receive an identification wristband that you must return at check-out. The wristband must be worn visibly throughout your stay to ensure security on the campsite and to prevent access by unauthorised persons. The registration number of the vehicle is required for registration. Pets must also be registered. If you arrive with a boat, this must also be registered.

Guests:

Visitors of already registered persons must always be registered. Day visitors can register during office hours from 8 am to 12 noon and from 2 pm to 7 pm and are permitted to stay until 10 pm. After submitting a valid ID, the data will be registered and a day wristband will be issued. Registered persons are obliged to check whether their visitors are registered, have left the campsite on time and have paid the daily fee, and are also liable for their behaviour on the campsite.

Dogs/cats:

Since 2021, dogs are only allowed in designated areas. Here, leashes are compulsory. We kindly ask you to inform us in advance if you are bringing your dog so that we can reserve a place. The places are limited and are located in the area between the playground and the restaurant. On all other pitches only dogs from permanent campers are allowed. Any soiling, even in front of the barrier, must be removed immediately by the dog owner using a hygiene bag. Walking paths are available outside the campsite. It is forbidden to walk dogs on the camping site. The beach area, the sanitary facilities and all common areas are off-limits for dogs. The same applies to cats.

Vehicles:

Cars and motorbikes must be parked next to the tent or caravan in such a way, that they do not obstruct traffic and neighbours. Only one car is allowed on each pitch, and this may only be parked on the pitch rented. For additional cars, the parking space in front of the barrier is available. In general, a walking speed of 5 km/h applies on the entire campsite. Please watch out for playing children. All roads and paths must be kept clear day and night for emergency vehicles. When reversing, you must be instructed by a person. Oil changes and washing of cars and caravans are prohibited on the campsite grounds. Charging electric cars and plug-in hybrids is prohibited on the entire campsite. An offence will be charged with a fee of € 100.00 as well as all costs still incurred on the electrical system.

Boats:

Watercraft must be registered at the reception. You will be provided with a numbered buoy for your stay, subject to availability and at a charge. The guest has no right to a buoy place. We strongly advise you to insure your watercraft against natural disasters. According to Law no. 19/1997, article 4, amended by Law no. 203 of 15.11.2011, all motorboats, longer than 2.5 m, requires a local licence plate.

Children:

Minors are to be supervised by their parents or a nominated full-aged person during their stay on the site. The children's playground is only for children up to the age of 12. Use of the playground equipment is at your own risk.

House rules:

In the exercise of the house rules, the management of the campsite may refuse to admit persons, expel them from the site or issue and enforce a permanent or temporary ban from the site if this appears necessary to maintain peace and security. Violations of the campsite rules entitle the campsite owner to immediate expulsion. In addition, the campsite management is entitled to terminate the contract without notice for good cause in order to enforce the campsite rules, in particular, if the guest insults or endangers other guests or the staff, disturbs the peace and order in the long term, expresses or behaves in a hostile or discriminatory manner, wilfully destroys, damages or removes the inventory of the campsite, is under the influence of illegal drug use, is intoxicated or if he/she behaves in any other way contrary to the contract.

Rest periods:

On holiday, rest and relaxation is one of the most important factors of all.

We therefore ask you to strictly adhere to our quiet hours, which are from 22.00 to 7.00 am and from 13.00 to 15.00 pm. The entrance and exit barrier is closed from 23:00 to 7:00 and from 13:00 to 15:00. Driving is generally prohibited during this time. Only camping staff are authorised to drive on the site. In case of emergency, the exit is possible at any time, in this case we ask you to inform the campsite management. Loud music, loud conversations, washing dishes, use of showers and all disturbances of peace are to be avoided during these times. Furthermore, it is forbidden to throw glass into the glass container during these times. From 23:00 onwards, all devices may only be operated in whisper mode. Conversation rounds are also to be discontinued. This will be checked by us for the benefit of the other guests. If, in our opinion, it is too loud, we will issue a warning. In case of infringement, we will make use of our domiciliary rights. However, in mutual respect for the other guests, such a warning should not even be necessary.

Departure:

In case of early departure, e.g. due to bad weather, work-related reasons, Mosquitos etc., the II booking period is payable.

Waste:

Waste must be disposed of separately in the rubbish bins provided at the waste station. The containers are marked accordingly, please dispose of household waste in the grid waste bins and not in the black containers.

Please always use rubbish bags. Only household waste may be disposed of which has arisen during your stay at the campsite. Disposal of bulky waste, camping chairs, tables, umbrellas, gazebos, awnings or similar items is strictly prohibited on the campsite.

Sanitary facilities:

Order and cleanliness are self-evident obligations of all campsite users. Therefore, we kindly ask you to leave the sanitary facilities and common rooms in this spirit. Water slides are available in the sanitary buildings for this purpose. Children under 6 years of age may only use the rooms if accompanied by an adult.

Wastewater/dirty water disposal:

There is a wastewater disposal station on our site for wastewater from motorhomes and caravans. Please dispose of your wastewater there. Emptying between 22.00 and 7.00 hrs is not permitted. Dirty water, rinse water and wastewater from cooking must not be emptied onto the lawn, onto trees or into manholes; these must be emptied into the drains provided. Discharging faeces is prohibited. Chemical toilets are to be disposed of in the sink at the camping building.

Barbecuing:

Barbecuing is only allowed on the whole campsite area and at any time of the year with an gas grill. Campfires, open fires and barbecues with charcoal are prohibited on the entire campsite grounds.

Electricity:

The use of a campsite offers many dangers and thus places increased demands on the caution of each individual camper. Cables and electrical equipment must be in perfect technical condition.

Gas test:

The gas systems and heaters in the motorhomes and caravans must comply with the G607 and must be serviced regularly by the camper. The corresponding proof of this must be presented to the campsite operator on request. The camper is liable for damage caused by the gas installations belonging to him or her.

Liability:

The camper and the persons accompanying him/her undertake to treat the rented pitch and all the buildings, facilities, inventory, etc. of the Lido Toce campsite with care. The camper shall be liable for any damage to the rented pitch, the rented property and the campsite's facilities and equipment, insofar as such damage is caused by him/her or by persons belonging to his/her household, visitors, etc. Any damage caused by the campsite guest must be reported immediately to the reception.

The campsite management accepts no liability for damage caused by gross negligence by third parties (theft, vandalism, etc.). Furthermore, within the scope of liability, we expressly point out that irregularities, damages or losses caused by branches, insects, other wild animals, weather conditions etc. may occur. No liability is accepted for damage caused by this or by force majeure (thunderstorms, hail, storms, floods, etc.). The campsite guest must have appropriate insurance.

Other:

Fastenings of any kind such as screws, nails, wire etc. must not be attached to trees and shrubs. The tensioning of ropes as well as clotheslines is prohibited. The railings may not be used for drying purposes. As you would certainly also like to find a well-kept lawn, it is not permitted to lay out air-impermeable tarpaulins or carpets.

WLAN is available on almost the entire campsite. The use of WLAN is an inclusive service of the campsite. There is no legal entitlement.

Storage of fuels or other hazardous materials is prohibited.

Feeding wild animals is strictly prohibited on the entire campsite as well as on the beach!
